A couple of errors have been identified on Bowlslink record of events concerning reconstituted teams, which team has played which opponent etc. The latter is likely due to permitted practice of side managers "flipping cards" for team selection but not updating Bowlslink.

Match Committee has received quite a few queries about COP and umpire type decisions.

Zone 5 2023/2024 Zone season calendar was ratified at our recent meeting. It was then forwarded to the State Match Committee for approval which was received on 8th March, 2023.

The calendar has been sent to all clubs.

Match Committee ran a survey to all 24 clubs asking whether they were or were not in favour of having a Men's Divisional Pennant.

Pennant Competition. 9 answered YES, 6 answered NO and 9 No Answer. ZMC decided that there will NOT be a 2023 – 2024 Men's Divisional Pennant Competition, however, this will be on looked at again in the following bowling season.

23 February 2023 Match Committee verified by email to all clubs:

After several discussions with all that have advised of the "UNFAIRNESS" of our (Match) ruling, also advice of the rules of the game according to the Umpires Chairman and the closeness of the commencement of our competition the Zone 5 Match Committee have reversed their "RULING" as per below.

We shall allow the flipping of cards by the side managers if they then alter the Teams in Bowlslink prior to posting results (scores), preferably the Teams be altered in Bowlslink prior to the commencement of the Game. Failure by any club to comply with the above then reverts to Teams as matched in Bowlslink will play against each other, Team 1 v Team1 etc.

NOTE: For the Zone Pennant playoff series and how the State Match Committee determine the draw at the State Pennant Finals remains as per Bowlslink Team 1 v Team 1 etc. No discussion on the fore and against scenario's will be considered for the above Pennant Playoff's.
